If arbitration is deemed unenforceable, you agree that any legal action or proceeding shall be brought exclusively in the federal or state courts located in **Shelby County**, **Tennessee**, and the prevailing party shall be entitled to recover its reasonable attorney's fees and costs.

#### 7. Miscellaneous

- **Severability:** If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
- **Entire Agreement:** This Agreement constitutes the entire understanding between you and Memphis Pool concerning promotional communications and supersedes any prior agreements.
- **Waiver:** No waiver of any provision of this Agreement shall be deemed a further or continuing waiver of such provision or any other provision.
